KRA Meeting Minutes

May 12, 2012

The May 12th KRA Meeting was dedicated to a forum for candidates who are running for Judge in the 18th Judicial District (Sedgwick County). Five of the six candidates were present as follows:

Division-1 Hon. Judge Phil Journey (Incumbent) vs. **Attorney Linda Kirby** (Challenger)

Division-2: Attorney Dave Dahl vs. **Attorney Faith Maughan** (Hon. Judge James Burgess' open seat) Faith Maughan was not present due to an out-of-state family funeral. Faith arranged for handouts to be available.

Division-20: Attorney Stephen J. Ternes vs. **Attorney David Calvert** (Hon. Judge Clark V. Owens' open seat)

After the call to order, a prayer was led by Scott Kliewer and the flag salute was led by Navy veteran, Dr. A.J. Morris. Those who are current office holders and candidates for various elective positions introduced themselves.

After the Treasurer's report, James Kilpatrick made a motion to accept it, and Craig Gabel seconded the motion, which carried. Al Aliston made a motion to accept the minutes as printed on the back of tonight's meeting agenda, and Cindy Koss seconded that motion, which also passed by a voice vote.

Tonight's forum began with an introduction of each judicial candidate. Each one made an opening statement. Written questions were taken from the audience, and President Mark Gietzen read the questions to the candidates. Many in the audience had very good questions, and the forum could have lasted much longer than it did, but was brought to a close because of the time.

Another item of business included a discussion on internet voting for KRA members to vote on candidate endorsements through the KRA website. After discussion, a vote was taken. Jeff Locke moved that the KRA maintain voting at the caucus events only, and not allow internet voting. Debbie Baker seconded the motion. Motion passed.

Craig Gabel announced training for Precinct Committeemen and women. Craig's training helps introduce people to the roles and responsibilities of precinct positions. Training includes campaign techniques to help them win their races, and the importance of having those party positions filled.

Closing announcements were made, and then Greg Rose moved to adjourn the meeting. Eric Henderson seconded the motion. Meeting adjourned at 8:40 p.m.
