KRA Meeting Minutes

June 14, 2012

After the call to order, Scott Kliewer opened this month's meeting with a word of prayer. The flag salute, led by Honorable Representative Les Osterman, was followed by an introduction of each of the candidates for public office who were present.

The first order of business was to give Senator Dick Kelsey his 2011 Lincoln Award, which was actually awarded to him during the December 2011 KRA meeting. However, since Senator Kelsey was in Topeka serving in the Legislature, he was unable to attend any KRA meetings until today. President Mark Gietzen had some very nice words for Dick as he presented the award. Dick expressed his appreciation.

Next Sheriff Bob Hinshaw spoke briefly about his campaign and the duties and responsibilities of being a Sedgwick County Sheriff. Afterwards he took questions from the audience, which resulted in a sometimes heated and vigorous exchange, quite typical of many recent KRA forums where softball questions are left at home. KRA President Mark Gietzen announced that he had made every attempt possible to schedule Sheriff Hinshaw's Primary opponent, Captain Jeff Easter. However, even after going to the extreme of offering Captain Easter any Thursday during the months of June or July, the good Captain was still unable or unwilling

to schedule a traditional forum with Sheriff Bob Hinshaw. Therefore, even without hearing from his opponent, the endorsement vote for Sedgwick County Sheriff was included in tonight's early Primary endorsements.

Following Sheriff Hinshaw's presentation, President Mark Gietzen opened a round table discussion regarding the three races that were under consideration in tonight's vote: Sedgwick County District Attorney, Sedgwick County Sheriff and 18th Judicial District Division-1. Numerous emotion filled opinions and strong recommendations were voiced by various voting members. The discussion was so rambunctious that James Hodges wisely interrupted the intense exchange with a motion to end further comments and proceed to balloting; Debbie Baker immediately seconded the motion. The motion passed unanimously.

The results were published in a News Release that was sent to statewide media outlets following the meeting.
