(Temporary Minutes sent via e-Mail) The May 9th KRA meeting featured the **Hon. Judge Phil Journey**, who spoke on Current events pertaining to 2nd Amendment issues in Kansas, national level successes and current challenges pertaining to the 2nd Amendment. Judge Journey also gave a brief 'future outlook' for 2nd Amendment protections in Kansas and at the federal level. (We had television news coverage that covered not just some segments of the meeting, which is common, but the ENTIRE meeting, from opening prayer to adjournment!)

President **Mark Gietzen** called the meeting to order at 7:00 pm. **Bill Spalding** led us in prayer and the oldest veteran present, **James Hudson** led the flag salute.

After a short introduction of everyone present, **Donna Machutta** moved to accept the minutes from last month's meeting, and **Bill Spaulding** seconded the motion. **Eric Henderson** moved

to accept the treasurer's report, and **Al Aliston** seconded the motion.

Mark Gietzen introduced the speaker, **Hon. Judge Phil Journey**, Vice President of the Kansas State Rifle Association. **Judge Journey** provided an in depth presentation of current issues involving 2nd Amendment rights in Kansas, as well as successes and challenges at the national level. A lively question and answer time brought up discussions involving the letter Governor Brownback received from Eric Holder, the rights of felons to own firearms, and questions about the Conceal Carry License process. Membership forms for the Kansas State Rifle Association were passed out, as well.

Mark Gietzen then opened the floor for old business and only the Fluoride issue was discussed. **Mark** then asked for volunteers regarding Fluoride-fights in local communities.
